



## ***Standard Limited Warranty***

### **1. Limited 5 Year Warranty**

Professional Audio Systems warrants to all original purchasers of PAS Products that all new PAS Products manufactured and sold by PAS shall be free from defects in material and workmanship for five (5) years after the date of delivery of the PAS Product to the original purchaser. If any such PAS Product becomes defective, malfunctions or fails to conform to this written Limited Warranty under normal use and service, and if the original purchaser complies with Paragraphs 4 and 5 of this Limited Warranty, then PAS will, without further charge, either repair or replace the PAS product.

### **2. Products Covered By This Warranty**

This Limited Warranty shall extend to all PAS Products manufactured and sold by PAS, but shall not extend to: a. any PAS Product without an inspection seal or a serial number, or with a defaced inspection seal or a defaced serial number.

### **3. Exclusions and Limitations**

This Limited Warranty shall not extend to, nor shall PAS be responsible for, damages of malfunction resulting from: a. accident, misuse, or negligent use; b. repairs or alterations made to the PAS Product outside PAS factory, or by anyone other than an authorized PAS service center; or c. improper installation.

### **4. Condition Precedent To Enforcement Of This Limited Warranty**

As a condition precedent to enforcement of this Limited Warranty, the original purchaser, must within ten days from the date of delivery of the PAS Product, execute and return to PAS the Warranty Registration Card attached to the PAS Product.

### **5. Enforcement Of Limited Warranty**

Any defective PAS Product shall be repaired or replaced pursuant to Paragraph 1 of this Limited Warranty by returning, with prior written return authorization, the defective PAS product, with transportation charges prepaid, to any PAS dealer, or authorized PAS service center in your area, or to PAS/Professional Audio Systems, 4233-A Lafayette Road, Indianapolis, IN 46254, Attn: Customer Service.

### **6. Implied Warranties Limited: Consequential Damages Excluded**

Any implied warranty in connection with any PAS Product hereby is limited in duration to the period of this Limited Warranty, PAS shall not be responsible for, nor does this Limited Warranty extend to consequential damage or incidental damages or expenses, including, without limitation, injury to persons or property, or loss of use. Some states do not allow limitations on the length of an implied warranty, and some states do not allow the exclusion of limitation of incidental or consequential damages, so the above limitation may not apply to you.

### **7. Acceptance**

Use of any PAS equipment, products, or services for five or more days shall create a conclusive presumption that such items meet all of the specifications for such items, and shall constitute full acceptance.

### **8. No Other Warranties Made**

This Limited Warranty is in lieu of all other express warranties of PAS, and does not assume, nor does it authorize any person to assume on its behalf, any other obligation or liability.

### **9. Other Rights**

This Limited Warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
